The Ronald McDonald House of Iowa City, located near the University of Iowa Children's Hospital, provided a "home away from home" to 1,075 families from around the world as they sought critical medical care for their children at nearby hospitals. The House provides a warm atmosphere and emotional support. The House provides 31 rooms, a large kitchen fully stocked with food and cooking supplies, three family lounges with entertainment facilities, free hospital parking, and other complementary amenities such as exercise equipment, computer and internet access, books and DVDs, laundry, van shuttle, a play room, and a large backyard with a playground. The House provided approximately 9,600 room days of service for the year.

In 2013, RMHC of Eastern Iowa and Western Illinois provided grants totaling \$69,486 to twenty-five Eastern Iowa and Western Illinois organizations that benefit the health and well-being of children. These grants benefited approximately 26,900 children in Eastern Iowa & Western Illinois.

The RMHC of Eastern Iowa and Western Illinois scholarship program provided 5 new \$2,000 one-time scholarships and 1 new multi-year college scholarships to deserving Eastern Iowa high school seniors in 2013. The program continued its multi-year scholarship commitment to 3 college students at a \$2,000 level for a total of \$18,000. As of December 31, 2013, there are 35 college students from Eastern Iowa that have previously benefited or are currently benefiting from the scholarship program.
