THE RONALD MCDONALD HOUSE OF IOWA CITY LOCATED NEAR THE UNIVERSITY OF IOWA STEAD FAMILY CHILDREN'S HOSPITAL, PROVIDED OVERNIGHT ACCOMMODATIONS, AMENITIES AND SUPPORT TO 663 FAMILIES FROM AROUND THE WORLD AS THEY SOUGHT CRITICAL MEDICAL CARE FOR THEIR CHILDREN AT NEARBY HOSPITALS. THE HOUSE PROVIDES 31 GUEST ROOMS, AN EVENING MEAL EVERY NIGHT OF THE YEAR, A LARGE KITCHEN FULLY STOCKED WITH FOOD AND COOKING SUPPLIES, THREE FAMILY LOUNGES WITH ENTERTAINMENT FACILITIES, FREE HOSPITAL PARKING, AND OTHER COMPLEMENTARY AMENITIES SUCH AS EXERCISE EQUIPMENT, COMPUTER AND INTERNET ACCESS, BOOKS, AND DVD'S, LAUNDRY, VAN SHUTTLE, A PLAY ROOM, AND A LARGE BACKYARD WITH A PLAYGROUND. THE HOUSE PROVIDED 10,165 ROOM DAY OF SERVICE DURING THE YEAR.
