### Budget & Finance Update

- New IT Vendor
  - a. Shannon Greene shared that we have been working with 3 vendors, but one dropped out into the process. Leaving us with 2 vendors, Wolf Technology and IP Pathways. Both quotes are coming in at approximately \$6,000 per month. There will also be an initial cost of equipment, anticipating we will need to purchase new equipment when we split from UI.
